Subject: Mode of payment to RCI for registration in Central Rehabilitation Register (CRR) by NEFT/RTGS only – reg.


Please refer to the Council's Circular No.9-14/Acctts/RCI dated 1st July, 2016 on the subject mentioned above in which provision for payment through NEFT in two bank account of RCI was provided.

2. It has been observed that applicants are still sending payment through demand draft/ depositing of Cash, which is not acceptable now.

3. To overcome the delay in verification of transaction, it has been decided to accept payment through NEFT/RTGS only to the Council's Bank Account of Canara Bank as detailed below. Earlier Punjab National Bank was also authorised by the Council to remit the fee, **but now payment through only Canara Bank shall be accepted.** The details of bank account of the Council for depositing the fee are given as under:

4. Payment made through **Cash deposit or Demand Draft shall not be accepted.** It shall be the sole responsibility of the applicant to follow the procedure.
